- Support the company's nutritionist and lab technician, analysing and interpreting results from the above sampling to assist with supplementation planning and adjustments during the year in response to changes in seasonal conditions and or production goals.
- Assisting the R&D team in any trial work through the monitoring and collection of data for reporting.
- Developing a thorough working knowledge of the uDOSE™, IoT devices and the uHUB dashboard to support DIT Customers
- Arranging supply and delivery of supplement including assistance with mixing of product on farm if required.
- Accurately completing paperwork for the company's accounts, inventory and asset management.
